The A15 EXP is designed for dry material collection while the A15 EXP W is equipped for picking up liquids and other wet hazardous materials. Both vacuums meet the requirements for use in Class I, Group D, and Class II, Groups E, F, and G environments. The units are made of 304 stainless steel and feature optional HEPA or ULPA filtration.

- Powered by compressed air for use where electricity is undesirable or unavailable.
- All stainless steel construction including container, filter chamber and trolley.
- Equipped standard with 50-foot air supply hose.
- Antistatic filter with large surface area and external filter shaker in the A15 EXP guarantees high filtration efficiency and prevents premature clogging.
- Optional downstream HEPA/ULPA filtration available on both units; Upstream HEPA available for dry model only. HEPA filter retains 99.97% of particles, down to and including 0.3 microns. ULPA retains 99.999% down to and including 0.12 microns.
- Non-sparking, conductive accessories are available to meet a wide range of hazardous cleaning needs.
